First up

3. Any updates to these Conditions of Entry will be subject to regulatory approval, and will be published on our website at www.tafeqld.edu.au, so it's important to check these Conditions of Entry regularly.

Who can enter ... and who can't

4. Any TAFE Queensland Staff member who has enrolled, completed both the pre and post program surveys, who has completed the program content and has printed the certificate of participation is eligible.

How to enter

5. To enter, you must follow the Entry Procedure.
6. We will not accept entries which are incomplete, illegible, or which are generated by computers or other automated means.
7. We reserve the right to disqualify your entry in the event of non-compliance with these Conditions of Entry or if, in our reasonable opinion, you tamper or interfere with an entry mechanism in any way.
8. If the Promotion cannot run for reasons beyond our control (for example, infection by computer virus, mobile network failure, bugs, tampering, unauthorised intervention, fraud, or technical failures), we reserve the right to cancel, suspend, modify or terminate the Promotion (subject to regulatory approval).
