If successful, you will be placed in a Magistrate Courthouse to experience the day-to-day operations of a busy Magistrate Court Registry. Whether you're a student or a career enthusiast, our program will help you gain invaluable insights into the Department of Justice and Attorney General (DJAG) and the court system.

#### **Additional Information**

In this program it is not anticipated you will be subjected directly to disturbing circumstances and material. You may, however, be exposed by talking with other employees who have had direct contact with such material or situations.

CSQ values the wellbeing of our workers and have a range of physical and psychological safety controls in place for all DJAG workplace environments. This includes strategies to manage the risk of workers being exposed to distressing events, material and/or vicarious trauma.

You should consider the above information and your personal resilience and coping strategies to sustain working in this environment, prior to application.

- Current resume outlining your education and/or work history, including contact details for two referees.
- A copy of your academic transcript.
- A copy of your clear criminal history check.
- Include your location preference.

#### **Experience Courts Program | cover letter guiding principles.**

**Conclude with a strong closing:** Summarise your key qualifications and express your eagerness to contribute to the ECP. Include a call to action, such as expressing your hope for an interview.

**Proofread carefully:** Ensure your cover letter is free of grammatical errors and typos. A well-written and error-free letter demonstrates professionalism and attention to detail.
