English Language Skills Requirements

To study nursing at TAFE Queensland, you must demonstrate that your English language skills will enable you to practice your profession safely. To be considered for entry into an approved Diploma of Nursing program, Australian Nursing and Midwifery Accreditation Council (ANMAC) accreditation requires that potential students have met the English Language requirements as outlined in the Nursing and Midwifery Board of Australia (NMBA) English language skills registration standard 2025.

These requirements include a written declaration that English is your primary language or evidence of achievement of the minimum <u>English language test</u> result as specified as specified in the NMBA English language skills registration standard.

Registration as a nurse with the Australian Health Practitioner Regulation Agency (AHPRA) is dependent on successful application to the Nursing and Midwifery Board of Australia (NMBA). To support your application, the NMBA may request evidence to demonstrate how you meet the English language skills requirements.

Two pathways are open to applicants into HLT54121 Diploma of Nursing with TAFE Queensland:

1. Primary language pathway (Section 1)

English is your primary language: You must have attended and satisfactorily completed at least **six (6)** years of **primary** and **secondary** education taught and assessed solely in English in a **recognised country**. At least **two years** of this education must have been between grades **7** and **12**. This **DOES NOT** include tertiary studies such as Vocational Education and Training or Higher Education.

Recognised Countries are listed on the Section 1: Primary Language Pathway Applicant Self-Declaration form.

OR

2. English language test pathway (Section 2)

English is NOT your primary language: You will need to provide evidence of an approved English Language Proficiency Test as part of your application: IELTS (academic module), Cambridge, TOEFL iBT, PTE Academic or OET and achieve the minimum scores outlined in the <u>NMBA's Registration Standard: English Language Skills March 2025</u>.

Approved English Language Proficiency Tests are listed on the Section 2: English Language Test Pathway Applicant Self-Declaration form.
