

CSQ SHORT COURSES PROGRAM

As a recipient of funding, TAFE Queensland is proud to support Construction Skills Queensland (CSQ) and their ongoing financial and professional contribution to the Queensland building and construction industry.

The CSQ Short Courses Program provides funding for a range of competencies and skill sets for existing and unemployed workers in the civil construction and building and construction industries who want to update or expand their skills and knowledge in specific areas.

HOW DOES IT WORK?

CSQ funding is paid directly to TAFE Queensland. Where CSQ funding doesn't cover the full cost of your fees, you will be required to contribute towards the remaining course fees.

WHAT'S ON OFFER?

Eligible participants can access a range of accredited and non-accredited short courses, with some courses forming part of full qualifications.

ACCREDITED SHORT COURSES

An accredited short course or skill set includes nationally recognised units of competency. These units may be applied as credits to a related qualification at a later date if you choose to study a full certificate or diploma. When you successfully complete your accredited unit/s you will be issued with a Statement of Attainment.

NON-ACCREDITED SHORT COURSES

Non-accredited short courses are a great way to increase your knowledge and increase your skills. Upon completion of a non-accredited short course a Certificate of Attendance can be provided.

ELIGIBILITY

To be eligible for funding, participants must be either an eligible worker, an eligible apprentice or trainee, or an unemployed eligible worker (i.e. unemployed for four years or less) in the civil construction or building and construction industries in Queensland who are one of the following:

- An Australian or New Zealand citizen
- A permanent resident of Australia
- A visa holder with the right to work in Australia (excluding international student visa holders)

Eligible workers must be employed in Queensland. Participants can only undertake a maximum of eight (8) Short Courses in total with completion before 30 September 2023. Limits apply to high risk work licences and mobile plant units.

Additional eligibility requirements may apply. Please contact TAFE Queensland for more information.
