

# **CSQ Skills Assessment and Gap Training Program**

As a recipient of Construction Skills Queensland's funding, TAFE Queensland are proud to support their ongoing financial and professional contribution to the Queensland building and construction industry.

The Construction Skills Queensland (CSQ) Skills Assessment and Gap Training Program provides funding for career seekers and existing workers in the civil construction and building and construction industries to access subsidised Recognition of Prior Learning (RPL) and gap training to gain an initial trade qualification.

#### How does it work?

CSQ funding is paid directly to TAFE Queensland. Where CSQ funding doesn't cover the full cost of your fees you will be required to contribute towards the remaining course fees.

Participants of the program will undertake a skills assessment to determine any RPL and gap training requirements.

The cost of RPL and gap training will depend on your individual skills assessment and the qualification you undertake.

Qualifications must be completed by 30 September 2025.

## Eligibility.

To be eligible for funding, participants must be eligible workers or unemployed eligible workers (i.e. unemployed for less than 6 months) in the civil construction or building and construction industries in Queensland and are one of the following:

- An Australian or New Zealand citizen
- A permanent resident of Australia
- A visa holder with the right to work in Australia and who has been working in the Queensland building and construction or civil construction industry for 6 months or more (excluding international student visa holders)

Eligible workers must be employed in Queensland.

Participants must be able to demonstrate RPL experience in 70% or more of the competencies required to complete the full qualification.

A participant must undertake a minimum of two (2) gap training competencies and a maximum of ten (10).

Additional eligibility requirements apply. Please contact TAFE Queensland for more information.

The Skills Assessment and Gap Training Program is an initiative of Construction Skills Queensland. Eligibility criteria applies to all CSQ funded programs.
